



## Bullies and Buddies Rescue Pet Adoption Agreement

I \_\_\_\_\_ agree to adopt \_\_\_\_\_, hereinafter referred to as Pet. I certify that I am adopting Pet solely for myself and/or my immediate family members living in my household. I agree that neither I nor any member of my family will sell, give away, donate or otherwise dispose of Pet to any person(s), business, medical facility, educational institution, or other entity for any reason whatsoever.

\_\_\_\_\_ (Initials) **I understand adopting a pet is a permanent decision and I agree to be the caretaker of this animal for the duration of the Pets natural life. Only in the event of extreme financial or physical hardship would I consider surrendering my pet. If at a future date I must surrender my pet, I agree to immediately contact Bullies And Buddies/Jennifer Rosen and surrender ownership of Pet back to her.**

\_\_\_\_\_ (Initials) If this animal is not micro-chipped, I will have this done within 2 weeks of adopting him/her. Jennifer Rosen shall be the secondary contact and I shall be the primary contact.

\_\_\_\_\_ (Initials) Pet must be spayed/neutered. I understand that if this procedure is not done before the adoption is complete (rescue is too young or not well enough for the surgery) I will allow Bullies And Buddies Rescue/Jennifer Rosen or a representative of Bullies And Buddies Rescue to pick this dog up at a reasonable time from my home and have such procedure done at Bullies And Buddies Rescue/Jennifer Rosen's veterinarian of choice. **I understand I have no ownership rights to this dog until such time as he/she is spayed/neutered and until such time, I am acting as a foster parent only.** If I decide to have the spay/neuter procedure done at the vet of my choice outside of the preferred Bullies and Buddies vets, I agree to pay in full for that procedure. I further agree to provide Bullies And Buddies/Jennifer Rosen with a copy of the spay/neuter certificate if this dog is spayed/neutered at a veterinarian of my choice (which will be incurred at my expense) within five days of such procedure.

\_\_\_\_\_ (Initials) I agree to keep one ID tag with Pet's name and a minimum of two contact numbers on my dog at all times.

\_\_\_\_\_ (Initials) I will NOT crop the tail or ears of this animal.

\_\_\_\_\_ (Initials) I agree to care for the above described companion in a humane and a responsible manner. I will provide him/her with clean and adequate shelter, food, water and veterinary care. I further agree that this animal shall reside inside my home and shall NOT be kenneled for extended periods of time. I agree to adequately supervise this dog outdoors. I further agree that this dog will not sleep outdoors, be tethered outdoors, nor be confined to any structure located outdoors.

\_\_\_\_\_ (Initials) I agree NOT to allow this animal to roam free beyond the confines of my enclosed property.

\_\_\_\_\_ (Initials) I agree to notify Bullies And Buddies/Jennifer Rosen immediately if this animal becomes lost, and if found I agree to work with Bullies And Buddies/Jennifer Rosen to prevent future occurrences of this nature.

\_\_\_\_\_ (Initials) In the event that I move from the location noted on this agreement or change my telephone number (s) for any reason, I agree to contact Bullies And Buddies Rescue/Jennifer Rosen to notify her of my new address and telephone numbers (s) within 15 days.

\_\_\_\_\_ (Initials) I agree that Bullies And Buddies Rescue/Jennifer Rosen may, at a mutually convenient time, make a follow up visit in order to ascertain that the above conditions have been satisfied.

\_\_\_\_\_ (Initials) I hereby agree to pay a non-refundable adoption fee of \$\_\_\_\_\_. I understand that this fee is a donation and assists in rescuing other needy animals and does not apply to this animals expenses.

\_\_\_\_\_ (Initials) Bullies And Buddies Rescue/Jennifer Rosen makes no representations or warranties (expressed or implied) nor any guarantee of this dogs health or behavior. Any damage physically or financially that I may incur will be my responsibility and liability upon execution of this agreement. Bullies And Buddies Rescue/Jennifer Rosen is not responsible for any damages or expenses related to the dog hereafter. I, my family, and household members agree to indemnify and hold harmless Bullies And Buddies Rescue/Jennifer Rosen for any actions which occur as a result of this dogs health, behavior, actions, or other circumstances or conditions related to him/her whether past, present or future.

\_\_\_\_\_ (Initials) I certify that all statements made by me on this adoption agreement are true and correct. I agree that Bullies And Buddies Rescue/Jennifer Rosen has the right to confiscate the above described animal in the event that any statements made by me are false.

\_\_\_\_\_ (Initials) Due to varying circumstances by which dogs are obtained, we have little or no medical history other than what is given to us by the shelters or previous owners. Due to the incubation period of certain diseases, viruses, and bacterial infections it is strongly advised that you keep your newly adopted dog away from other animals for at least 14 days after adoption. Your adopted dog maybe incubating an infectious disease, virus, or bacterial infection that does not show clinical signs at the time of adoption.

\_\_\_\_\_ (Initials) Do not contact Bullies And Buddies Rescue/Jennifer Rosen for any health related issues or medical advice as she is a rescue only, not a licensed veterinarian. Bullies And Buddies Rescue/Jennifer Rosen can provide guidelines and answer basic questions. Her recommendations cannot be used as medical advice and are not intended to diagnose, treat, cure, or prevent any disease. If your animal is showing signs of illness or you have concerns regarding his/her health please contact a licensed veterinarian. We can provide referrals based on specific conditions.

\_\_\_\_\_ (Initials) Some animal diseases can infect humans (zoonotic diseases.) Examples of these diseases include rabies, roundworms, hookworms, fungal infections ( i.e. ringworm, scabies, plague, toxoplasmosis, etc.) Your veterinarian is an excellent source of information on the prevention of these diseases. The web sites of the Los Angeles County Veterinary Public Health, the California Department of Food and Agriculture, and the Center for Disease Control are other sources of information.

\_\_\_\_\_ (Initials) Your adopted companion animal may have behavioral problems that may or may not have been evident during his/her stay with us. If you elect to keep the dog, any treatment or training to correct the dog's behavioral problems is the responsibility of the new owner.

\_\_\_\_\_ (Initials) **If said pet is surrendered back to Bullies And Buddies/Jennifer Rosen you agree to give Bullies And Buddies/Jennifer Rosen two weeks notice and will pay for boarding (at a facility of Bullies And Buddies/Jennifer Rosen's choice) until said pet is placed into a proper foster home and/or adopted. This shall include any costs for training of said pet.**

\_\_\_\_\_ (Initials) Breach of agreement/liquidated damages. In the event that you do not comply with the terms of this agreement, or the dog is abused or neglected, we hold the right to recover the dog from you upon demand and the dog will be surrendered to us immediately. In addition, without waiving any of our rights under this agreement, if you do not surrender the dog to us, you will owe us a payment in the amount of \$5,000 agreed between us as just and reasonable liquidated damages to compensate us for our costs and expenses in connection with your breach of this agreement and we reserve the rights to reacquire the dog.

\_\_\_\_\_ (Initials) With your agreement to this adoption and signed adoption receipt, you hereby release Bullies And Buddies/Jennifer Rosen and agents from any liability and claim you have, whether known or unknown now or in the future in connection with your adoption, ownership and disposal of any dog adopted from Bullies And Buddies Rescue/Jennifer Rosen.
